1.3 Goals:

- informing broader population about consequences of active and passive smoking
- motivating for changes in behaviour
- informing broader population about advantages of smoke free workplaces



- presentation of data from situation analyzes-podatkov analiz stanja and scientific researches and unity with EU tobacco politic trends
- motivating employers to prohibit smoking in work organizations(Smoke-free Workplaces!)
- connecting NGO, co-operation with foreign NGOs, granting the exchange of experience and good practices
- educating volunteers, involved in performed activities for a specific population
- forming suitable messages in the sense of informing
- usage of written media, radio, TV, Internet, preparing web pages
- co-operation with governmental institutions

Effects evaluation:

- public opinion questionnaires
- interviews
- radio and TV shows

Achieved effects of the programme are not different from the ones we planned!

1.4 Method, results and evaluation.

Opinion questionnaire (public research) in the first half of realization of the project – May 2005-analysis

Opinion questionnaire (public research) in the second half of realization of the project-September 2005-analysis

Open phone: 1h30min radio show in Maribor and TV show (1h) in Ljubljana - October 1005
(Analysis of public opinion, added DVD,CD)

Evaluation of response from informing employers in catering inns is possible to realize in the period after realizing the project/programme.

Influence of SCTC on acceptance of supplementing Tobacco Law will be possible to evaluate in the next year.

Public (society) is deficiently informed about the consequences of active and passive smoking.

Public is deficiently informed about possibilities of help you can get when you are trying to stop smoking.

High school youth is not getting systematically satisfactory information (schools).

Existing legislation is not considered and performed correctly and leaves doubts. Research shows the desire for total prohibition of smoking in the catering inns, prohibition of selling tobacco products to children younger than 18 years, and possibilities of selling tobacco products only in specialised stores.

Work in progress:

Additional public informing about expected supplementation of Tobacco Law.

Additional educating for volunteers who visit and inform employers.

Performing public shows (festivals, conferences, concerts and other mass-media events).

Letters to Slovenian Parliament members to support and except the Tobacco Law supplements.

Connection with Slovenian Ministry for Health, Slovenian NGOs and Health-Syndicates.
